Subject: Direct Certification Process Information for SY 2018-2019 and Webinar Date

Direct Certification (DC) is the process of identifying, via electronic matching, school age children who are members of households receiving assistance under NJ-SNAP, (Food Stamps), TANF, (Temporary Assistance) or FOSTER CARE programs, to certify them as eligible for free meal benefits in the school nutrition programs. This matching process is done in the School Nutrition Electronic and Reimbursement System, (SNEARS). The link to perform DC for the 2018-2019 School Year will be available beginning July 15, 2018.

Below are the requirements for all School Food Authorities (SFAs) participating in the National School Lunch and/or School Breakfast Program, for the 2018-2019 school year. **Please note the dates below and the file upload process for DC for this upcoming school year:**

1. Direct Certification **must be done a minimum of four times** during the school year according to the following time schedule:

1. **July 15<sup>th</sup> – August 30, 2018**
2. **September 1<sup>st</sup> – September 30, 2018**
3. **October 1<sup>st</sup> – October 30, 2018**
4. **March 1<sup>st</sup> – March 30, 2019**

**SFAs are strongly encouraged to do the matching process monthly. This will increase the total number of DC students, therefore reducing the total number of applications to determine and verify.**

2. Direct Certification must be done using a student enrollment file upload into the SNEARS web-based system.

There are two file upload processes to choose from, **depending on the SFA's total enrollment with access to meals:**

1. **Batch Process:** SFAs whose total enrollment (with access to meals) is greater than or equal to 1000 must use the Batch Process. This will allow large SFAs to upload multiple enrollment files at the same time for processing. The system will send a notification e-mail to the SFA when the files are ready to view to complete the matching process. The turnaround time may take up to twenty-four hours.

2. **Regular DC Process:** SFAs whose total enrollment (with access to meals) is less than 1000 can use either the batch process or the regular DC process to obtain direct certification matches the same day.

SFAs that do not comply with the Direct Certification requirements will be notified by email. Failure to comply will result in reimbursement funds being placed on hold until requirements are met.
