An Administrative Review of the School Nutrition Programs will be conducted during SY 2019-2020.

The Administrative Review is now managed through our new Schools Online Administrative Review System (SOARS), which can be accessed through the "myNewJersey" portal. The SOARS system allows five approved users (Certifier, Alternate Certifier, Submitter, Alternate Submitter and Food Service Director). Usernames and passwords will be emailed to each approved user to access the SOARS system the first week of September. Please ensure that all e-mail addresses are updated in SNEARS by August 31, 2019.
